## AN ADVOCATE FOR WOMENS RIGHTS?


QUESTION 2: Following her husband's November 1978 election as Governor of Arkansas, Rodham became First Lady of Arkansas in January 1979, her title for twelve-(12) years (1979–1981, 1983–1992). In 1979, Rodham became the first woman to be made a full partner of Rose Law Firm. From 1978 until they entered the White House, she had a higher salary than that of her husband. During 1978 and 1979, while looking to supplement their income, Rodham engaged in the trading of cattle futures contracts; an initial \$1,000 investment generated nearly \$100,000 when she stopped trading after ten months. In the wake of Hillary Rodham Clinton's stature as First Lady of Arkansas for twelve-(12) years, did women prosper as well as Hillary Rodham Clinton?

**RESPONSE:** In 2004 and again in 2009, The Institute for Women's Policy Research (IWPR) published the report, "The Status of Women in the States." The 2009 report found that Arkansas ranked between 47th and 50th on most measures examined. The table below lists IWPR's findings:

**CONCLUSION:** Although *Hillary Rodham Clinton was clearly able to prosper socially, politically, and financially during her twelve-(12) years as First Lady of Arkansas*, the overwhelming majority of women – especially women of color – did NOT prosper during or in the wake of Hillary Rodham Clinton's tenure as First Lady of Arkansas. Hillary Rodham Clinton's so-called commitment to women's issues is, at best, a bunch of crap. Next, Hillary Rodham Clinton served as U.S. Senator from New York from January 3, 2001 to January 21, 2009. Next, Hillary Rodham Clinton served as U.S. Secretary of State from January 21, 2009 to February 1, 2013. In the wake of Hillary Rodham Clinton's stature as First Lady of the United States for eight-(8) years, her tenure as U.S. Senator from New York for eight-(8) years, and U.S. Secretary of State for four-(4) years did Black people prosper as well as Hillary Rodham Clinton?



**RESPONSE:** Absolutely not; in the wake of Hillary Clinton's twenty-(20) years of public service sitting at the pinnacle of political and economic power in the United States, Black people have <u>not</u> progressed as a direct result of assistance or unilateral action from Hillary Rodham Clinton. Hillary Rodham Clinton was there, and is there. She could have been a major advocate and catalyst to improve the economic and social plight of Black people – but she did not, has not. Nothing has changed.
